

Terms and Conditions

Welcome, and thanks for joining and using EBG | Community.

We are a social network and online platform for sourcing, procurement and finance professionals as well as consultants.

Our mission is to connect experts and practitioners to allow them to be more productive and successful. Our services are designed to connect you to other professionals to meet online, exchange ideas and content, learn and be part of a network of trusted relationships. The Community is based on those having attended an EBG Summit (this may change but is the starting point in 2021).

Below are the terms and conditions you accept when using EBG | Community. You also agree to our Privacy Policy, which covers how we collect, use, share, and store your personal information.

1. Parties

You are a “User” of our services. Registered Users of our Services are “Members” and unregistered users are “Visitors”. This Agreement applies to both.

Your agreement is with EBG e-BusinessGuide AB in Sweden acting under the umbrella name EBG | Network.

2. Acceptance

You agree that by clicking “Join Now” “Sign Up” or similar, registering, accessing or using our services you are entering into a legally binding agreement.

If you do not agree to this Agreement, do NOT click “Create New Account” (or similar) and do not access or otherwise use any of our Services.

3. User Agreement and Obligations

Users agree to the following conditions in using the services.

You shall:

- a use the Services in a professional manner.
- b use your real name on your profile;
- c keep your password secure and confidential;
- d choose a strong and secure password;
- e comply with all applicable laws, including, without limitation, privacy laws, intellectual property laws, anti-spam laws, export control laws, tax laws, and regulatory requirements;

- f follow our rules;
 - g only provide information and content that you have the right to share, and that your profile will be truthful;
 - h only provide content or information if that does not violate the law nor anyone's rights (e.g., without violating any intellectual property rights or breaching a contract);

- You shall not:
- j share an account with anyone else;
 - k transfer your account (including with connections or within groups);
 - l act dishonestly or unprofessionally, including by posting inappropriate, inaccurate, or objectionable content;
 - m create a false identity on EBG | Community;
 - n misrepresent your current or previous positions and qualifications;
 - o misrepresent your affiliations with a person or entity, past or present;
 - p misrepresent your identity, including but not limited to the use of a pseudonym;
 - q create a Member profile for anyone other than yourself (a real person);
 - r use or attempt to use another's account;
 - s harass, abuse or harm another person;
 - t send spam or other unwelcome communications to others;
 - u scrape or copy profiles and information of others through any means (including crawlers, browser plugins and add-ons, and any other technology or manual work);
 - v act in an unlawful, libelous, abusive, obscene, discriminatory or otherwise objectionable manner;
 - w disclose information that you do not have the right to disclose (such as confidential information of others (including your employer));
 - x violate intellectual property rights of others, including patents, trademarks, trade secrets, copyrights or other proprietary rights;
 - y post any unsolicited or unauthorized advertising, "junk mail," "spam," "chain letters," "pyramid schemes," or any other form of solicitation unauthorized by EBG e-BusinessGuide AB (under the umbrella name EBG | Network);
 - z post anything that contains software viruses, worms, or any other harmful code;
 - aa reverse engineer, decompile, disassemble, decipher or otherwise attempt to derive the source code for the Services or any related technology, or any part thereof;
 - bb use manual or automated software, devices, scripts robots, other means or processes to access, "scrape," "crawl" or "spider" the Services or any related data or information;
 - cc engage in "framing," "mirroring," or otherwise simulating the appearance or function of the Services;
 - dd override any security feature of the Services;
 - ee interfere with the operation of, or place an unreasonable load on, the Services (e.g., spam, denial of service attack, viruses, gaming algorithms).

You are responsible for anything that happens through your account unless you close it or report misuse.

4. Notices and Service Messages

Users consent to us using our websites, mobile apps, and email to provide you with important notices. This Agreement applies to mobile applications as well. Users agree certain additional information can be shared with us.

If the contact information you provide is not up to date, you may miss out on these notices.

Users agree that we may access, store and use any information that you provide in accordance with the terms of the Privacy Policy and your privacy settings.

By submitting suggestions or other feedback regarding our Services, you agree that EBG | Network can use and share (but does not have to) such feedback for any purpose without compensation to you
